



The Legal Professions Program is designed first and foremost to prepare you for a successful college experience. In addition, we provide general insights into legal careers from law enforcement to legal practice to corrections, with an emphasis on the criminal justice system.

**Qualifications**

**New Visions students should:**

- be academically strong
- satisfy graduation requirements
- demonstrate an interest in the education field
- exhibit maturity, responsibility and ability to work both independently and in teams
- be prepared to engage in extensive reading assignments both in and out of the classroom
- be prepared to work extensively on writing skills through assigned written projects
- be prepared to participate in class discussions and presentations on a daily basis
- plan to attend college or pursue other post-secondary education

**Course of Study**

- Participate in the Assigned Counsel Program, where you represent actual clients in Auburn City Court.
- Learn about investigations and evidence-gathering techniques from current law enforcement officers, and apply them to mock scenes involving traffic stops, motor vehicle searches, motor vehicle accidents, and major crimes.
- Research and argue landmark and current legal issues in first and appellate level court situations.
- Observe the environment and interact with current practitioners through field trips to different courts, correctional facilities, and law enforcement departments.
- Learn the political, social and business implications of a budget process, and apply that knowledge to the economics of a family, a business, and various government entities. Students will also learn about investments and savings, and how preparation in those areas can affect their future.
- Analyze fact situations in depth and be able to organize and argue points-of-view both verbally and in writing.
- Learn how to improve your community through a monthly volunteer service learning project.

**What is a Professional Studies Program?**

A Professional Studies Program is a total immersion approach to education that integrates English, Government, Economics and Career Exploration into one program of study. The program places high school seniors in the actual working environment of their preferred career areas.

**Advantages**

The New Visions program supplements the final year of high school for talented and motivated students allowing them to experience a variety of educational fields. A portion of the students' morning is spent at their component high school attending chosen classes. Students then arrive at their designated New Visions site for their program from 10:00 a.m. – 2:00 p.m. Students are encouraged to continue to participate in extracurricular activities at their home schools.
